Step 2: Submit required documents:

- Proof of income: Copy of all family members 2019 Federal 1040 form (page 1 only). If you don't have this, we will work on alternative documentation.
- Proof of date of birth: Copy of child's birth certificate or other official document.
- Proof of residency: Copy of current utility bill with mailing address or driver's license.
